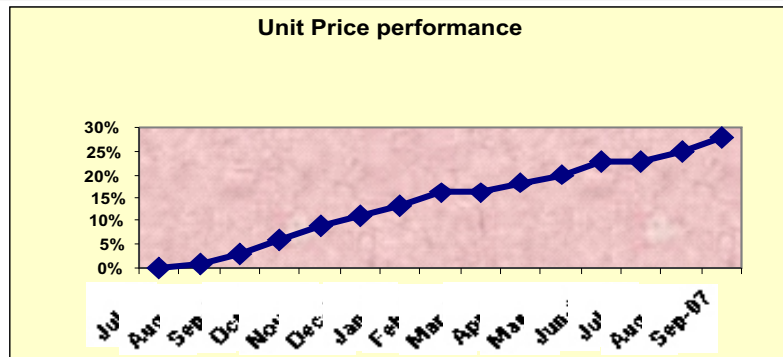
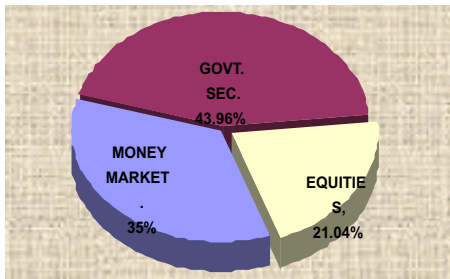

## Investment Report

The unit price of the CPL Value Fund closed at N1.2744, a growth of 1.7% when compared with its August 2007 unit price of N1.2529. This represents a cumulative return of 27% on the Fund, launched in July 2006 at N1.00. At a cumulative return of 27%, the Fund sustained its monthly growth rate of 2% in the 3rd quarter and average quarterly growth rate of 5%. As at 30 September 2007, the fund assets were allocated as follows: Government Securities (43.96%), Money Market (35%), Ordinary Shares (21.04%).



## Industry and Regulatory Update

PenCom has commenced the remittance of accrued rights of Federal Public Sector employees between July and December 2007. The RSAs of those retired in July and August have been credited with their accrued rights PenCom has cleared and remitted funds to PFAs on 20,826 records out of 83,806 records so far generated in the ongoing revalidation exercise of public sector employees records

- Your account number is as stated in the quarterly account statement.
- Your PASS CODE is 1234
- The POUND KEY is this symbol #  
You must end all your input with the POUND KEY
- For confidentiality, it is advisable you change your PASS CODE the first time you make the call.
